Adopted Exempt Amendments to the Rules Governing Workers' Compensation Rules of Practice, Minnesota Rules, Chapter 5220 and Workers' Compensation Medical Services and Fees, Minnesota Rules, Chapter 5221; and Reimbursement of Supplementary Benefits, Insurance Verification, and Loggers Targeted Industry Fund, Minnesota Rules, Chapter 5222.	
Subject matter	The Minnesota Department of Labor and Industry proposed technical amendments under the Good Cause rulemaking procedure of Minn. Stat. §14.388. The amendments were made to rules governing workers' compensation rules of practice, penalties, medical services and fees, reimbursement of supplementary benefits, insurance verification and loggers targeted industry fund. The amendments were made to conform to statute and rules changes, and to replace obsolete terms and references to the following rules: <i>Minnesota Rules</i> , Parts 5220.2525 (new); 5220.2570, subparts 7 and 11; 5220.2630, subpart 4, items A and C; 5220.2720, subparts 2 and 3; 5220.2740, subpart 4; 5220.2750, subparts 2 and 3; 5220.2760, subpart 1, item C; 5220.2770, subparts 1, 2 and 3; 5220.2780, subpart 3; 5220.2810, subpart 4; 5220.2820, subparts 3 and 4; 5220.2830, subpart 3; 5220.2840, subpart 4; 5220.2850; 5220.2920, subpart 6; 5220.2930, subpart 5; 5221.0600, subpart 4; 5222.0400, subpart 2, item B; 5222.2001, subpart 1; 5222.3001, subpart 2 (new).
