1. Call to Order, Chair

- A. The meeting was called to order by Chair Becker at 9:34 AM. Roll call was taken by the Secretary and a quorum was declared with 12 of 13 voting members present in person or via WebEx. Parizek's audio through the WebEx was not working until item 5D.
- B. Announcements Introductions (members and attendees) Chair Becker
 - Everyone present in person and remotely are able to hear all discussions.
 - All votes will be taken by roll call if any member is attending remotely.

2. Approval of meeting agenda

A motion was made by Abrahamson, seconded by Lemke, to approve the agenda with the following revision to 5C as follows: RFI PB0172 (instead of RFI PB0171). The roll call vote was unanimous with 11 votes in favor; the motion carried.

3. Approval of previous meeting minutes

A motion was made by Arnold, seconded by Pylkas, to approve the Apr. 16, 2024, meeting minutes. The roll call vote was unanimous with 11 votes in favor; the motion carried.

- B. Department update Mike Westemeier
- C. RFI PB0172 Scott Thompson (Section 909.0 Special Venting for Island Fixtures) see **Attachment B.**
 - Mr. Thompson said he is a plumber and lead instructor for My Plumbing Training, providing continuing education throughout Minnesota, North and South Dakota. Section 909.1, island venting, is always a challenge in Minnesota. Some inspectors allow the handwritten drawing submitted in RFI PB0172 saying it meets code compliance. However, other inspectors say it doesn't meet code requirements and they won't allow it. He would like the Plumbing Board to review the drawing. Does the drawing meet code requirements and is it okay to do island venting as shown in the drawing?
 - The Board and Mr. Thompson discussed how to best state the question.
 - Abrahamson suggested this could fall under alternative means and methods to meet code requirements.
 - Chair Becker said so the question could be, does the submitted sketch meet the
 code, the letter of the code? He does not think the drawing meets the letter of the
 code. Does it meet the intent of the code? He would say most likely, but it would
 come back to what the Plumbing Board is ultimately tasked with by statute the
 Board's role is to interpret the code as it's written.
 - Abrahamson made a motion, but it was withdrawn.
 - After further discussion, the Board and Thompson agreed on how to state the question as follows:
 - Question: Does the drawing submitted with PB0172, in which the island vent does not connect to the horizontal drain immediately downstream, comply with section 909 of the Minnesota Plumbing Code?
 - Answer: No, the return vent is required to connect to the horizontal drain immediately downstream of the fixture drain per section 909.1 of the Minnesota Plumbing Code.

- Analysis: Installations omitting the connection to the horizontal drain immediately downstream could be submitted under section 301.3 of the Minnesota Plumbing Code, Alternative Means and Methods, for approval by the Authority Having Jurisdiction.
- A motion was made by Arnold, seconded by Pylkas, to answer the above question with no, the return vent is required to connect to the horizontal drain immediately downstream of the fixture drain per 909.1. The roll call vote was unanimous with 11 votes in favor; the motion carried.
- D. Officer nominations and elections
 Election of Officers (Meeting turned over to Mike Westemeier, Commissioner's Designee)
 - Chair

Erickson nominated Becker. The roll call vote was unanimous with 11 in favor and one abstention (Becker); the nomination passed. Becker was re-elected as Chair. (The Board was able to hear Parizek through WebEx at this point through the remainder of the meeting).

Vice-Chair

Becker nominated Erickson for Vice-Chair. The roll call vote was unanimous with 12 in favor; the nomination passed – Erickson was re-elected as Vice-Chair.

Secretary

Becker nominated Abrahamson for Secretary. The vote was 12 in favor; the nomination passed – Abrahamson was re-elected as Secretary.

Unlicensed Lakeville contractor fined \$48,000

 A Lakeville contractor was found to have engaged in residential remodeling and roofing activities without a license. The contractor was ordered to cease and desist from the unlicensed activities and fined \$48,000.



- A Grand Forks, North Dakota, contractor was found to have performed unlicensed plumbing work. The contractor was ordered to cease and desist from the unlicensed activity and fined \$3,500, of which \$3,000 was stayed contingent on full future compliance.
- A St. Peter contractor was found to have performed plumbing, electric, remodeling and mechanical work without having the required contractor licenses and bonding. The contractor was ordered to cease and desist from the unlicensed activities and fined \$10,000.
- A Merriam, Kansas, contractor was found to have engaged in residential remodeling activities without the
 required license. The contractor was ordered to cease and desist from the unlicensed activities and fined
 \$6,000, of which \$3,000 was stayed contingent on full future compliance.
- A licensed residential building and electrical contractor operating out of St. Paul and Stillwater was found
 to have breached contracts with multiple homeowners. The contractor was ordered to cease and desist
 from acting as a residential building contractor, from performing electrical work in Minnesota, and both
 licenses were revoked.


