Computation of fixed-fee permit surcharges

Where the fee for the permit issued is a fixed amount the surcharge is equivalent to 1/2 mill (.0005) of the fee or \$1.00, whichever is greater.

Computation of valuation-based permit surcharges

Where the fee for the permit is based upon valuation the surcharge is as follows:

\$1,000,001 to \$2,000,000	\$500 + .0004	X (valuation - \$1,000,000)	
\$2,000,001 to \$3,000,000	\$900 + .0003	X (valuation - \$2,000,000)	
\$3,000,001 to \$4,000,000	\$1200 + .0002	X (valuation - \$3,000,000)	
\$4,000,001 to \$5,000,000	\$1400 + .0001	X (valuation - \$4,000,000)	
\$5,000,001 or more	\$1500 + .00005	X (valuation - \$5,000,000)
