In an Order on Review of Rules dated February 25, 2016, ALJ Liman approved the revisions to Minnesota Rules Chapter 7511, except for part 7511.1101.6, which was disapproved. The Department submitted revisions to Chief Judge Pust on March 25, 2016, with the modifications recommended by ALJ Eric Lipman. ALJ Lipman and Chief Judge Pust approved the revised submissions on April 1, 2016.</p>
