- 4715 – Amendments to Plumbing Code. Rules become effective on October 31, 2012.
- 4716 – Licensing & Registration. Rules become effective on November 27, 2012. CCLD has sent out Master renewal notices along with Backflow Certification renewals. Journeyman should receive backflow notification next year along with their license renewal information.
- 4716 – Expedited Rulemaking for RPZ Tester/Rebuilder certification. Comment period ends on 10/17/2013 with two comments received to date which will be reviewed at the Board meeting.
- 4716 – Rulemaking for RPZ Tester/Rebuilder Certification Continuing Education. No progress has been made.

Complaints – None have been received.

Plumbing Board meeting agenda – Parizek reviewed the agenda. RFI-PB0068 will be reviewed at the Board meeting under special business. Parizek will ask to amend the agenda to include a closed session with legal counsel after the committee reports but prior to special business PB0068.
