1.6 Subp. 4. **Adjustments.** On October 1, 1994, and on October 1 of each succeeding  
1.7 year, the fees in this part must be adjusted by the percentage determined under Minnesota  
1.8 Statutes, section 176.645, in the same manner as the conversion factor of the relative value  
1.9 fee schedule is adjusted under Minnesota Statutes, section 176.136. This provision does not  
1.10 apply to expenses under subpart 3, item E, subitem (1). The fees shall be adjusted as follows:

1.12 V. on October 1, 2015, the fees adjusted in item U shall be increased by 0.6  
1.13 percent; and

1.14 W. on October 1, 2016, there shall be no further adjustment to the fees set forth

1.17 percent.
