# Minnesota R3.1 EDI XML



The Minnesota Department of Labor and Industry will adopt the International Association of Industrial Accident Boards and Commissions (IAIABC) Release 3.1 XML format claims reporting standard Feb. 9, 2023.

### **EDI learning objectives**

### Minnesota is adopting IAIABC claims R3.1 XML format Feb. 9, 2023

The adoption of the new XML format includes minimal data changes from the current MN R3.1 reporting and is mostly represented by two new DNs.

- 1. DN0438 Collective Bargaining Agreement Code
- DN0440 Withheld Attorney Fees Current, and the associated DN0092 Benefit Adjustment Code valid value 4 = withheld attorney fees



#### **DN0438 – Collective Bargaining Agreement Code**

The new DN is used to report Union Construction Workers' Compensation Program (UCWCP) claims and will replace a complicated Campus process that did not work.

- Previously, Campus required that a trading partner must report UCWCP claims by sending the value 06 in DN0207 and code 4 in DN0208 for Managed Care Organizations.
- Now trading partners will report UCWCP claims directly using the DN0438 Collective Bargaining Agreement Code, where the Y = Yes code denotes a UCWCP claim.



#### **DN0440 – Withheld Attorney Fees – Current**

The new DN is used to report potential contingent attorney fees being withheld from the employee's benefits in the likelihood that the claim administrator will have to pay the employee's attorney.


- Previously, claims could have a net weekly amount not equal to the gross weekly amount which accounted for the withheld attorney fees.
- Now trading partners will report an adjustment code for withheld attorney fees and then put the adjusted amounts into the withheld attorney fees current. When the fees are paid out to the employee, the employee's attorney, or both, then the withheld attorney fees – current will return to zero dollars.

#### **DN0440 – Withheld Attorney Fees – Current, payment scenarios**

When paying back withheld attorney fees to the employee or the employee's attorney, Campus accepts benefit type code (BTC) 500 – Unspecified Lump Sum, the 5xx benefit type code related to the benefit type the fees were withheld from, or even the original 0xx benefit type initially reported.

- Example 1: BTC 050 -TTD and 070 TPD is withheld during claim. Then BTC 500 unspecified lump sum is paid back for all BTCs.
- Example 2: BTC 050 -TTD is withheld during claim. Then BTC 550 TTD lump sum is paid.
- Example 3: BTC 050 TTD is withheld during claim. Then BTC 050 TTD is paid.



# Direct connect trading partners and EDI vendors will test the new XML format in November and December 2022

Claim administrators should be prepared to report the new mandatory conditional DNs and all senders should ensure they are prepared to transmit the new XML IAIABC format by Feb. 9, 2023.



# Annual claims for reimbursement will require FROI and SROI update report (UR) filings

- Starting Feb. 9, 2023, annual claims for reimbursement will also require FROI and SROI update report (UR) filings making the claims up-to-date.
- The URs that update claims will make the processing of claim payments faster and accurate.
