

Contractor Inspection Fee Worksheet for Existing Multi-Family Dwelling

The minimum fee for each separate inspection is \$55. The fees below represent our best estimate of the minimum fees required based on the information you provide, and the most common fees charged. These calculated fees may not accurately represent all the required inspection fees. Any fee discrepancies will be reviewed by the inspector and you will be billed for the difference.
