I am writing to formally request relief from the final order issued by OSHA on March 18th, 2025, regarding Inspection No. 318213667. The final order was issued due to the late filing of my Notice of Contest related to the citation issued on 2/5/25 OSHI ID: P6108 Citation 01 Item 002, Citation 01 Item 003 and Citation 01 Item 004.

The delay in filing the Notice of Contest was due to my illness, which prevented me from responding within the required 20- day period. Upon recovering and realizing the missed deadline, I promptly contacted OSHA to address the situation and express my intent to contest the citations noted above. I also sent via e-mail on Citation 01 Item 001 the mandatory progress report, proof all abatement guidelines were met, and payment in full of the penalty amount of \$800.00

Under Federal Rule of Civil Procedure 60(b)(1), relief from final order may be granted due to excusable neglect. Given that the delay resulted from a legitimate health-related issue beyond my control, I respectfully request that the final order be vacated, and that I be granted the opportunity to file my Notice to Contest.

Granting this petition will not prejudge OSHA's enforcement efforts or compromise public safety. Allowing my contest to proceed will ensure that I can fully exercise my rights while maintaining compliance with OSHA's regulations.

I am committed to addressing any deficiencies identified during the inspection and have taken steps to strengthen compliance procedures within my company.

In light of these circumstances, I respectfully request that OSHA grant relief from the final order, vacate the order, and permit the filing of my Notice of Contest.
